I do not have much to report. I participated in two Conference calls. I will be attending Regional Delegates Meeting next weekend and World Service Conference in April. I will have more to report at Assembly May 19, 2012.

COORDINATOR AND STANDING COMMITTEE REPORTS AND CONVENTIONS

ALATEEN- No report

ARCHIVES- No Report

FORUM- Sharon B was unable to attend. Sandy gave her report for her.. She asked us to make sure meetings are sharing the copies of the Forum that is being sent to the group.

GROUP RECORDS- Phil H - I am now able to access our Group Records online, directly from the WSO database. This gives us the most up to date information available at any time.

As of 9:00 PM, March 16, 2012, Ohio Area has:

441 active Al-Anon Groups – of these there are 4 groups that hold multiple meetings, that is more than one meeting a week. One group has 6 meetings a week and 3 groups have 3 meetings a week.

Of those groups, 152 have submitted annual updates so far – 34%, 19 groups in a “no mail” status – mail sent to the Current Mailing Address (CMA) has been returned as “unable to forward”. Groups remain in “no mail” status for a period of two years. 119 groups in an “inactive” status – groups that have been in a “no mail” status for over two years are put on inactive status. In addition, when WSO is notified that a group is no longer meeting, it is placed on “inactive” status as well.

21 groups that are “marked for deletion” – groups that have been on inactive status for over one year with no activity, and are scheduled to be deleted from the WSO database. Once a group’s WSO ID number is deleted, it cannot be retrieved.

As of February 8, 2012, we also have:

40 Active Alateen groups

1 Alateen group in a “no mail” status

3 Alateen groups in an “inactive” status

In addition, of the 441 active Al-Anon groups, there are 278 groups with GR’s listed (63%). I cannot guarantee that the GR information is totally correct because I haven’t had time to go through and compare the WSO database against the old database in the old laptop computer. My energies have been focused on ensuring the CMA addresses and GR addresses meet USPS “standards”, and verifying the actual name and location of the Group meeting places, by using Map Quest, Google Maps, Yellow Book dot com, etc.

I have the district reports on my laptop and can print them off for the DR’s that are here.

LITERATURE- Shirley M was absent. Ginny C reported that a timely reprint “Parents Of Alcoholics” (R-18) will be coming out soon. Sharings on the “Intimacy” publication are still being accepted. The B-22 “How Al-Anon Works” will have a page added, talking about the “3 C’s”. The Legacies Workbook is due out July, 2013.

PUBLIC OUTREACH- Sandy reminded everyone of the upcoming Addiction Studies Institute, to be held August 22-24 in Columbus. She asked all Districts NOT in an Al-Anon Information Service (AIS) to please send 50 copies of their meeting schedules to her by August 1. AIS’s were requested to send 100 copies to her by August 1. The schedules are handed out to the professionals attending the Institute.

WSO has 42 Alateen groups registered in Ohio. As of 3/17/12 only 6 Sponsors have re-certified. I received a list from WSO of all certified Al-Anon Members Involved In Alateen Service (AMIAS) Last year there were 267 AMIAS and/or Sponsors certified. So far only 44 AMIAS have re-certified.

All reports of who is re-certifying must be sent to WSO by June 15th. I must have all paperwork, including fingerprinting, by June 1st in order to have them to WSO by the 15th.

NEW BUSINESS

- Group Records Coordinator Phil H presented a Knowledge Based Decision Making proposal to “align AFG Of Ohio’s current mailing address with that of the World Service Office”. Basically, this proposal would mail the all communications from AFG of Ohio to the Group’s Current Mailing Address instead of the Group Representative. The Committee voted in favor of preparing a motion for the Spring Assembly to consider.
- ASI Task Force Co-Chair Marissa D presented a Knowledge Based Decision Making proposal to make funding the ASI an annual budget line item, rather than coming to the Assembly every year asking for funds to participate. The Committee voted in favor of preparing a motion for the Spring Assembly to consider.
- There was discussion about the \$20,000 CD that’s coming due April 7th. The Budget Committee recommended the CD be reinvested in two \$5000 and one \$10,000 CD’s with varying expiration dates.

Motions

Motion 2012-1 – For a three year trial, starting in 2013, include funding for the Addiction Studies Institute as a budget line item. This will allow participation without prior Assembly approval each year as is required when funding is taken from the Action Committee/ Coordinator’s Fund as has been done in 2010, 2011, & 2012

Motion 2012-2 – Authorize expending the proposed amount of \$704 from the Action Committee/Coordinator’s Fund for participation in the 2012 Addictions Studies Institute, And or additional \$325.00 from the Equipment Fund for a Retractable Banner Stand for use at the Addictions Studies Institute and all other events.

Motion 2012-3 –Move to align AFG of Ohio current mailing address with that of the World Service Office. That is mail will go to the CMA instead of the GR; AWSC & DR's will still receive mailings as before
