

AL-ANON FAMILY GROUPS OF OHIO
SAFETY AND BEHAVIOR REQUIREMENTS FOR ALATEEN SPONSORS ,ALATEENS,
AND ANY ADULT INVOLVED IN ALATEEN SERVICE

1. EVERY AL-ANON MEMBER INVOLVED WITH ALATEEN SERVICE MUST:
 - A. BE AN AL-ANON MEMBER REGULARLY ATTENDING AL-ANON MEETINGS.
 - B. BE AT LEAST 21 YEARS OLD
 - C. HAVE AT LEAST TWO YEARS IN AL-ANON IN ADDITION TO ANY TIME SPENT IN ALATEEN
 - D. NOT HAVE BEEN CONVICTED OF A FELONY, AND NOT HAVE BEEN CHARGED WITH CHILD ABUSE OR ANY OTHER INAPPROPRIATE SEXUAL BEHAVIOR, AND NOT HAVE DEMONSTRATED EMOTIONAL PROBLEMS WHICH COULD RESULT IN HARM TO ALATEEN MEMBERS

2. THERE MUST BE AT LEAST ONE ALATEEN SPONSOR AT EVERY ALATEEN MEETING

3. THE AREA REQUIREMENTS PROHIBIT OVERT AND COVERT SEXUAL INTERACTION BETWEEN ANY ADULT AND ALATEEN MEMBER

4. THE AREA REQUIREMENTS PROHIBIT CONDUCT CONTRARY TO APPLICABLE LAWS

5. THE AREA REQUIREMENTS CONTAIN PROCEDURES FOR PARENTAL PERMISSION AND MEDICAL CARE WHEN APPLICABLE
 - a. CONSENT FORMS MUST BE SIGNED BY A PARENT/LEGAL GUARDIAN WHENEVER ANY ALATEEN MEMBER IS TRANSPORTED TO/FROM ANY OUT OF TOWN AL-ANON/ALATEEN MEETINGS OR EVENTS.
 . A NOTORIZED CONSENT/MEDICAL RELEASE FORM IS REQUIRED FOR ANY OUT OF TOWN AL-ANON/ALATEEN EVENT. THE FORM MUST BE FOR THE SOLE PURPOSE OF A SPECIFIC MEETING/EVENT. A COPY OF THE CONSENT FORM MUST BE KEPT IN POSSESSION OF THE PERSON WHO IS PROVIDING THE TRANSPORTATION OR ACTING AS CHAPERONE.

6. THE AREA REQUIREMENTS MUST BE REVIEWED BY LOCAL COUNSEL
